All members are informed that:

1. The ordinary and special business as stated in the Notice of 24<sup>th</sup> AGM may be transacted through voting by electronic means.
2. The remote e-voting shall commence on 27<sup>th</sup> September, 2019 at 9.00 A.M and ends on 29<sup>th</sup> September, 2019 at 5.00 P.M.
3. The cut-off date for determining the eligibility to vote by electronic means or at the AGM is Monday 23<sup>rd</sup> September, 2019.

Any person, who acquires shares and becomes a member after dispatch of the Notice of 24<sup>th</sup> AGM and holding shares as of the cut-off date i.e 23<sup>rd</sup> September, 2019, may obtain the login ID and password by sending a request to [helpdesk.evoting@cdslindia.com](mailto:helpdesk.evoting@cdslindia.com). However if a person is already registered with CDSL for e-voting then existing user ID and password can be used for casting vote.

Members may note that:-

- a) The remote e-voting module shall be disabled by CDSL after the aforesaid date and time for voting and the remote e-voting shall not be allowed beyond the specified period.
- b) The facility of voting through ballot paper shall be made available at the AGM for the members who have not cast their vote by remote e-voting.
- c) The members who have cast their vote by remote e-voting prior to the AGM may also attend the AGM but shall not be entitled to cast their vote again at the meeting.
- d) A person whose name is recorded in the register of members or in the register of beneficial owners maintained by the depositories as on the cut-off date shall be entitled to avail the facility of remote e-voting or voting at the AGM through ballot paper.
